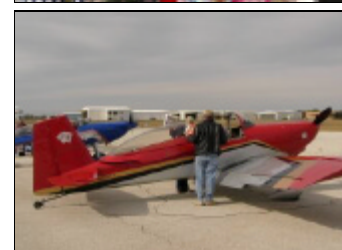
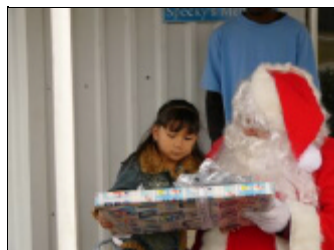

So, you want to donate an airplane ride to a charity?

My church was planning a social event that also included a silent auction to raise funds for the youth group activities. So,.... you guessed it. I thought I'd donate a local sightseeing flight.

As a private (not commercial) pilot I checked with AOPA first as I thought there may be some issue with money being involved, even though I would never see or touch any. Sure enough, there is a long list of requirements. First there are the normal currency requirements (*No not \$\$\$*) for both pilot and aircraft. No problem, I'm current. However, 200 hours of flight time is also required and I'm presently at 166. So, no donating a flight this time. The church loses, the public loses an opportunity to experience general aviation, and GA loses a potential future pilot.

There are also paperwork requirements placed on the pilot and the charity that make this almost more trouble than it is worth, especially for a single flight! Plus, there is currently an FAA Proposal For Rule Making that would increase the minimum flight time requirement to 500 hours. A new instrument rated pilot wouldn't qualify to take someone up for a VFR charitable flight!

Here is a thumbnail sketch of what is presently required.

Pilot in command: Minimum = Private, current and valid medical, current per 14 CFR61.56 & .57, 200 hours, has not participated in more than 4 similar events during the current calendar year. (*Don't dare donate at 5 events or face the FAA!!!*)

Aircraft: Standard airworthiness cert., be airworthy and comply with subpart E of part 91. Check with your insurance carrier too!

Airport: Must be a public airport adequate for the aircraft to be used or another airport that has been approved by the FAA for the operation.

Sponsor: Charitable org must be identified as such by US Dept of Treasury.

Drug Testing: AOPA Members-Only Exemption: Prior to event, AOPA member must submit the Online Request Form. (After the event, all pilots involved must submit their names to AOPA.) AOPA will respond with a sample agreement for review by my attorney! Within 7 days after the event the Charity Flight Drug and Alcohol Testing Exemption Form must be sent to AOPA.

Sponsor: Notifies FSDO at least 7 days before event. Sponsors signed letter must include; Name of sponsor, purpose of charitable event, date, time, location, photocopy of pilots certificate, medical, logbook entries re 200+ hours.

After the event: Complete and submit AOPA Exemption Form. AOPA submits the form to the FAA. Each pilot involved is required to have a logbook entry for each charitable event.

This is our government, reaching into our lives to protect us from ourselves. They are raising the barrier higher and higher that separates the general public from the joy and freedom of flight, and reinforcing the perception that flying is only for the rich and famous, out of reach for the common man. As if there was not already enough government regulation regarding aviation...
